Date: March 17, 2008

Pursuant to rules adopted by the National Executive Board of the National Postal Mail Handlers Union, Local 300 has conducted an election of delegates for the 2008 Convention.

On February 13th, 2008, the Judges of the 2008 Delegate Election mailed ballots to all eligible voters. The candidates whose names appeared on the ballot were certified by the Judges. The deadline for the return of ballots was 10:00 am March 13th, 2008, at PO Box 1000, Peck Slip Station, New York, NY 10272-1000

The counting of the ballots took place commencing at 10:30 am on March 13 & 9:15 am March 14th, 2008, at 111 John Street, Suite 710, New York, New York, 10038, in the presence of candidates.


The Judges received a total of 1290 returned envelopes. Of these 97 were voided and not counted for the following reasons:


- 53 Envelopes did not contain the voter's name
- 6 Could not identify voter
- 0 Original and duplicate ballots received, and only the later received ballot was counted
- 30 Ballots received from ineligible voters
- 8 Ballots were improperly filled out
- 97 Total Ballots received but not counted;

Therefore, the total number of ballots counted was 1193.

The following 40 members of Local 300 were elected as delegates to the 2008 National Convention in Orlando, FL - August 11 through August 16, 2008.
